Junior Showmanship Handler Competition

SUNDAY, MARCH 30, 2025

Junior Showmanship Classes shall be:

- (A) Novice. This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.
- (B) Open. This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.
- (C) Master. This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if win has been disallowed or Jr. miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

Take Hwy 114 West to Boyd/Bridgeport, TX

Turn South on FM 730 approximately 7 miles to Briar Road, turn left, 1 block to Tri-County Dog Training.

SHOW REGULATIONS

The show site will be accessible at 4:00 PM, Friday, March 28, 2025

The show site will be accessible at 8:00 AM, on Saturday, March 29, 2025 and Sunday, March 30, 2025

A recording fee of 50 cents will be required for each dog entered at any license or Member Club show, obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (American Kennel Club Rules, Chapter 14, Section 2).

Entry fees are \$30.00 for regular classes., \$28.00 for Puppy Classes and Bred By Exhibitor. These fees include a \$3.00 event fee and a 50 cent American Kennel Club recording fee. Sweepstakes entry fee is \$15.00. Veterans classes are \$15.00. Junior Showmanship is no charge.

All checks need to be payable to Dog Show in a Box and received no later than March 12, 2025 at 6 pm CST.

Dogs entered in the American Bred Classes must have been whelped in the United States by reason of a mating which took place in the United States (American Kennel Club Rules, Chapter 6, Section 8).

Foreign dogs (dogs not whelped in the USA or Canada) are eligible for Puppy and Open Classes effective, January 1, 1985.

Telephone, telegraph, fax and unsigned entries cannot be accepted. Entries not on official entry forms and photocopies of entry forms without Agreement and Rules on the reverse side of the official AKC entry form are not accepted.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging may be excused.

Owners are responsible for errors in making out entry forms, regardless of whoever may make such errors. No entry fee will be refunded in event of such error or cancellation of entries after the published closing date.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge or because of riots, civil disturbances or any other cause beyond the control of the club.

The show giving club, or their members, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.
