The show site will be accessible at 3:00 PM, Friday, March 7, 2025
The show site will be accessible at 8:00 AM, on Saturday, March 8, 2025 and Sunday, March 9, 2025.

A recording fee of 50 cents will be required for each dog entered at any license or Member Club show, obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. (American Kennel Club Rules, Chapter 14, Section 2).

Entry fees are \$31.00 for regular classes., \$28.00 for Puppy Classes and Bred By Exhibitor. \$15,00 Veteran Class, These fees include a \$3.00 event fee and a 50 cent American Kennel Club recording fee. Sweepstakes entry fee is \$15.00. Junior Showmanship and Pee Wee no charge.

Dogs entered in the American Bred Classes must have been whelped in the United States by reason of a mating which took place in the United States (American Kennel Club Rules, Chapter 6, Section 8).Foreign dogs (dogs not whelped in the USA or Canada) are eligible for Puppy and Open Classes effective, January 1, 1985.Make all checks and money orders payable in U.S. funds to Dog Show In A Box. Checks or money orders must be sent with entries.

Telephone, Telegraph, fax and unsigned entries cannot be accepted. Entries not on official entry forms and photocopies of entry forms without Agreement and Rules on the reverse side of the official AKC entry form are not accepted.

Return checks do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$35.00 to the amount of each returned check. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging may be excused.

Owners are responsible for errors in making out entry forms, whoever may make such errors. No entry fee will be refunded in event of such error or cancellation of entries after the published closing date. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge or because of riots, civil disturbances or any other cause beyond the control of the Club. The show giving Club, or their members, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.

Classes and Divisions.

The regular Junior Showmanship Classes shall be:

Novice Junior
Open Junior
Master Junior

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919)233- 9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5–9 years of age. Children younger than five cannot participate in the Pee Wee Class Special Attraction.

The safety of the children is a primary concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- At a Group or Specialty Club Show the dogs must be of the breed(s) eligible for the event.
- A dog must be registered to participate.
- Entry must be pre-entered and stated in the additional class box on the AKC entry form.

In addition to an entry, a release must be signed by the child's parent or legal guardian. Release form will be available from the show secretary at the event prior to judging. The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience—no Junior /Pee Wee will be "judged" but rather will be mentored with the age-appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. Obviously, the older children can absorb more detail than the younger ones. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation ribbon or rosette to commemorate the experience. The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to lift a table breed on or off the table, or the Club may mandate that the adult should do it regardless. .
