Show hours are from 8:00 AM to 11:00 PM. The show site will be accessible at 8:00 AM, Friday April 25, 2025.

A recording fee of 50 cents will be required for each dog entered at any license or Member Club show, obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (American Kennel Club Rules, Chapter 14, Section 2).

Entry fees are \$32.00 for regular classes, \$25.00 for Puppy Classes, \$17.00 for-Veterans class. These fees include a \$3.00 event fee and a 50 cent American Kennel Club recording fee. Dogs entered in the American Bred Classes must have been whelped in the United States by reason of a mating which took place in the United States (American Kennel Club Rules, Chapter 6, Section 8).
